THE VICTIMCONNECT RESOURCE CENTER AND THE DC VICTIM HOTLINE ASSIST VICTIMS WITH LEARNING ABOUT THEIR RIGHTS AND OPTIONS CONFIDENTIALLY AND COMPASSIONATELY THROUGH A TELEPHONE BASED HELPLINE, AN ONLINE CHAT, AND TEXT MESSAGING. THE CONNECT DIRECTORY PROVIDES A FAST AND EASY WAY FOR VICTIMS TO LOCATE SERVICE PROVIDERS SPECIALIZING IN SPECIFIC AREAS OF VICTIMIZATION IN A WIDE VARIETY OF JURISDICTIONS THROUGHOUT THE COUNTRY. THE VICTIMS RESOURCE GUIDE PROVIDES INFORMATION ON AVAILABLE VICTIMS SERVICES ACROSS THE COUNTRY, AND THE TRIBAL VICTIMS SERVICES PROJECT ENSURES THAT TRIBAL GOVERNMENTS AND LAW ENFORCEMENT ENTITIES CAN ACCESS RESOURCES FOR VICTIMS OF CRIME UNDER THEIR JURISDICTION.
